



Gaelscoil na Lochanna

Ráiteas Polasaí Covid 19

Tá Gaelscoil na Lochanna tiomanta d'ionad oibre sábháilte agus sláintiúil a sholáthar dár bhfoireann go léir agus timpeallacht foghlama shábháilte dár ndaltaí uile. Chun sin a chinntiú, tá an Plean Freagartha COVID-19 seo a leanas forbartha againn. Tá an BOM agus foireann uile na scoile freagrach as an bplean seo a chur i bhfeidhm agus cuideoidh an comhiarracht le scaipeadh an víris a chuimsiú. Déanfaimid:

- leanúint de mhonatóireacht a dhéanamh ar ár bhfreagra COVID-19 agus an plan seo a leasú i gcomhairle lenár bhfoireann
- faisnéis reatha a sholáthar dár bhfoireann agus do dhaltaí ar an gcomhairle Sláinte Poiblí arna eisiúint ag FSS agus Gov.ie.
- faisnéis a thaispeáint ar chomharthaí agus ar airíonna COVID-19 agus ar theicnící cearta glanadh na lámhe
- aontú leis an bhfoireann, ionadaí oibrithe atá furasta a aithint chun an ról atá leagtha amach sa phlean seo a chomhlíonadh
- gach ball foirne agus dalta a chur ar an eolas faoi riachtanais riachtanacha sláinteachais agus riospráide agus faid fhisiciúil
- an scoil a oiriúnú chun fadú fisiceach a éascú de réir mar is cuí de réir threoirí na Roinne Oideachais
- logáil teagmhála a choinneáil chun cabhrú le rianú teagmhála
- a chinntiú go dtéann baill foirne i dteagmháil leis an bhfaisnéisiú ionductaithe / clár taitheochta a sholáthraíonn an Roinn Oideachais
- na nósanna imeachta comhaontaithe atá le leanúint a chur i bhfeidhm i gcás duine a bhfuil comharthaí COVID-19 air agus é ar scoil
- treoracha a sholáthar don fhoireann agus do dhaltaí le leanúint má fhorbraíonn siad comharthaí agus comharthaí COVID-19 le linn am scoile
- glanadh a chur i bhfeidhm de réir chomhairle na Roinne Oideachais

Rachfar i gcomhairle le foireann uile na scoile ar bhonn leanúnach agus spreagtar aiseolas ar aon imní, saincheistanna nó moltaí.

Is féidir é seo a dhéanamh tríd an Ionadaí / na hIonadaithe Oibrithe Luaidhe, a dtacófar leis de réir an chomhaontaithe idir an Roinn agus comhpháirtithe oideachais.



Covid 19 Policy Statement

Gaelscoil na Lochanna is committed to providing a safe and healthy workplace for all our staff and a safe learning environment for all our pupils. To ensure that, we have developed the following COVID-19 Response Plan. The BOM and all school staff are responsible for the implementation of this plan and a combined effort will help contain the spread of the virus. We will:

- continue to monitor our COVID-19 response and amend this plan in consultation with our staff
- provide up to date information to our staff and pupils on the Public Health advice issued by the HSE and Gov.ie
- display information on the signs and symptoms of COVID-19 and correct handwashing techniques
- agree with staff, a worker representative who is easily identifiable to carry out the role outlined in this plan
- inform all staff and pupils of essential hygiene and respiratory etiquette and physical distancing requirements
- adapt the school to facilitate physical distancing as appropriate in line with the guidance and direction of the Department of Education
- keep a contact log to help with contact tracing
- ensure staff engage with the induction / familiarisation briefing provided by the Department of Education
- implement the agreed procedures to be followed in the event of someone showing symptoms of COVID-19 while at school
- provide instructions for staff and pupils to follow if they develop signs and symptoms of COVID-19 during school time
- implement cleaning in line with Department of Education advice

All school staff will be consulted on an ongoing basis and feedback is encouraged on any concerns, issues or suggestions.

This can be done through the Lead Worker Representative(s), who will be supported in line with the agreement between the Department and education partners.
